To Our Dear Residents and Family Members:

We want to remain transparent and provide you updates on the situation at **Windber Woods Senior Living and Rehabilitation Center and The Gardens, Personal Care Home at Windber Woods** regarding COVID-19. The safety and well-being of our residents is our top priority. We are doing what we can to limit the spread of COVID-19 within our facility. Please check our website to obtain facility updates.

Windber Woods identified the first new case on August 20, 2023. The Facility has a cumulative TOTAL OF **60 RESIDENTS AND 36 STAFF** who have confirmed cases of COVID-19.

The Gardens, Personal Care Home at Windber Woods has identified the first new case on October 10, 2023. The Gardens has a cumulative **TOTAL OF 4 RESIDENTS AND 0 STAFF** who have confirmed cases of COVID-19.

As of 11/21/2023

- **0 new residents and 0 new staff members** are confirmed with COVID-19 from last week's report, which are reflected in the above total cases.
- **96 of the 96 cases** are considered recovered.
- Of the above recovered cases, **there was a total of 0 deaths in Nursing related to COVID-19** that passed away at the home or another location.
- **Windber Woods has had greater than a 14-day window since the last case.**

The Gardens at Windber Woods Personal Care Center cases of COVID-19 are listed below:

As of 11/21/2023:

- **0 new residents and 0 new staff members of Windber Woods Personal Care Home** are confirmed with a COVID-19 diagnosis and are reflected in the above total cases.
- **4 of the 4 cases** is considered recovered in Personal Care.
- There has been 1 death in Personal Care related to COVID-19.
 - **Personal Care has had greater than a 14-day window since the last case.**

NO FURTHER WEEKLY UPDATES WILL BE POSTED UNLESS A NEW OUTBREAK OCCURS.

Windber Woods Senior Living and Rehabilitation Center follows all guidance set by the Centers for Disease Control and Prevention (CDC), the Center for Medicare and Medicaid Services (CMS), Local and State Department of Health, including return to work criteria for staff who tested positive and other measures related to Covid-19. Due to government privacy requirements, we cannot divulge specific information about the individuals who have confirmed or suspected COVID-19.
